- c. Biography.
- d. Professional resume.
- e. Copy of current basic training record (BTR).
- f. Copy of page 11, 12 and 13 from OMPF.

On 5 Feb 1983, you treated a subordinate not as a recruit/bat where alcohol was served. Your lack of ability to lead and control this Marine was evident. Your judgment was obscured and you became distracted by your night activities. Subsequently, the Marine, who is underage and has had prior alcohol related incidents, engaged to obtain and drink alcohol. The next day, this Marine was O.A. from work as a result of being passed out and at lunchtime, operated the vehicle until he was pulled over by an MP for speeding. The MP detected a strong odor of alcohol coming from his breath and received him. After being transported to HQ, this Marine submitted to a chemical analysis and registered a .03 BAC. This behavior from a Marine Corporal brings discredit not only on the unit, but also the United States Marine Corps. This type of leadership, or the lack thereof, is detrimental to unit cohesion, good order and discipline and will not be tolerated. Furthermore, your judgment is below the expectation of what a Marine NCO should possess; future displays of negligence will result in disciplinary action. Specific recommendations for corrective action: Review the Handbook for the Marine NCO, re-familiarize yourself with the Core Values of Honor, Courage and Commitment. Tie the heart to the head and pattern your career around the Leadership Traits and Principles. Attend the nonresident PME course when scheduled, do not violate the UCMJ and seek assistance, which is available through the chain of command. I am advised that failure to take corrective action or any subsequent infractions may result in disciplinary action, administrative separation and/or limitation of further service.
