ABCANZ: Pub 21	<i>Design and Test for Military Bridge and Gap Crossing Equipment</i>	4 Mar 2024	Pub 21 covers loading, design, and testing requirements to be used for the development of military clear-span bridges, piers, floating bridges, rafts, equipment causeways and erecting and launching structures that are part of the equipment. It's used to confirm equipment will meet the performance specified by the user.
