

GROUND SUPPLY SCHOOL CAREER LEVEL COURSE COMMAND SCREENING CHECKLIST

Information: Resident MOS schools are not screening institutions. In order to prevent Marines from being turned away upon arrival, it is essential that parent commands ensure their Marines are fully qualified and satisfy the enrollment prerequisites set forth in MCO 1553.2D and this checklist. Failure to satisfy any of the prerequisites on this checklist disqualifies a Marine from attending a course.

Action: The completed Command Screening Checklist will be hand-carried to the school and maintained in the Marine's student academic record until completion of the class.
